On November 1, 2016 the Issuer filed a Statement of Claim in the Ontario Superior Court of Justice under Court File No. CV-16-562698 against its former Chief Executive Officer, Mr. Gary Brown, and a company controlled by Mr. Brown. The Corporation is seeking damages in the amount of \$619,147 for breach of contract and additional damages in the amount of \$643,230 for negligence and breach of fiduciary duty.
