**On November 1, 2016 the Issuer filed a Statement of Claim in the Ontario Superior Court of Justice under Court File No. CV-16-562698 against its former Chief Executive Officer, Mr. Gary Brown, and a company controlled by Mr. Brown. The Corporation is seeking damages in the amount of \$619,147 for breach of contract and additional damages in the amount of \$643,230 for negligence and breach of fiduciary duty.**

**There are significant uncertainties regarding the price of copper, gold, molybdenum and other minerals or metals and the availability of equity financing for the purposes of mineral exploration and development. The prices of copper, gold, molybdenum and other minerals or metals are subject to constant market fluctuation to the point where it has become difficult for companies to raise new capital. The Issuer's future performance is largely tied to the development of its current mineral properties and the overall financial markets. Current financial markets reflect ongoing concerns about the stability of the global economy as well as ongoing concerns about the stability of the global economy. As a result, the Issuer may have difficulties raising equity financing for the purposes of mineral exploration and development.**
